Director's Report for January 6, 2016

- Reserved Louisville Sr. Center for Saturday, March 12 for Member/Volunteer Appreciation Event
- Opened Pay Pal account & contacted WireBuilt to add on-line donation/membership button on our website; now functional
- Wrote winter newsletter; distributed 202 copies through personal emails, 12 USPS mailings and many more via Cassgram, KCCB website and on-line community newsletters
- Completed America Recycles Day report to KAB
- Received notification from NDEQ of \$1,578 grant from the 2016 Litter Reduction & Recycling Grants Program (will be used for litter cleanups)
- Received notification from NDEQ of \$37,887 grant from the 2016 Litter Reduction & Recycling Grants Program
- Participated in CURC (College & Univ. Recycling Coalition) webinar: "Quantifying Your Waste Reduction Efforts" Case study presentations included Univ. of North Carolina: Asheville's "Shareable Campus" program, a Waste Free Office Move effort at Knox College, and Loyola University Chicago's initiative to reduce vendor packing with Reusable Totes. All three campuses used interns to help track and audit waste along with monthly reporting required from waste haulers. Positives: used reusable totes/containers or reused cardboard boxes on campus for supplies, collected extra office supplies & furniture for reuse, used tray free dining, water bottle & plastic bag ban, initiated producer take-back programs, started compost program, recycled books, collected surplus food & textiles for local YMCA's & daycares.
- Held meeting with Andy Harpenau, Gretna Sanitation, and Andy Farber, Louisville School Supt., for discussion of starting recycling program at the school. Food compost pilot program may be a possibility in fall.
- Louis. Schools will use the county recycling trailer from Conestoga Schools to start the program; KCCB will offer educational assistance to begin program.
- Contacted Dept. of Roads & all but one of our "No Litter" signs have been installed
- Set up "Litter Hotline" program with Cass Co. Sheriff & KNB; delivered 30 litter bags to the sheriff's
 office
- Participated in EPA webinar: "Managing Recycling Contamination." *Education* is key to prevent contamination & use totes with lids to help. Top contaminates: film- plastic bags (by far the worst), scrap metal, cords (tanglers), food waste, rigid plastics, broken glass, & weather.
- Sent membership forms to 9 people on USPS newsletter list
- Participated in "Voluntary Mercury Thermostat Take-Back Programs" call with Product Stewardship Institute. To achieve high recovery rates, government agencies & other entities take the following action: provide financial incentives, implement supporting policies, increase convenience, reach out to interested parties, & educate key stakeholders.
- Received reimbursement of DEQ Qrt. 3 grant spending Dec. 24
- Paid bills & purchased supplies to complete 2015 DEQ Litter Grant funding
